As she finishes each class (e.g. Novice in Trial 1 she will begin Novice Trial 2) This will be followed by Trial 1 and 2 Interiors Novice-Elite with the same procedures. We will have no same day move-ups but we will have move-ups between Saturday and Sunday.

**Awards:** Qualifying ribbons, rosette ribbons for 1<sup>st</sup> through 4<sup>th</sup> place for Level A exhibitors, strip ribbons for 1<sup>st</sup> through 4<sup>th</sup> place Level B exhibitors, Title rosette ribbons.

**Directions to the site:**

Wolverine Dog Training Club, 20782 Orchard Lake Road 48336; From the west: Take M14/I-96 past I-275 to Merriman Road exit. Turn left (north) on Merriman Rd. and continue 4 miles to just past 8 Mile Rd. Turn right into second driveway. (Note: Merriman Rd. changes its name to Orchard Lake Rd. north of 8 Mile.) From the south take I-275 to 8 Mile Rd. exit. Turn right on 8 Mile and go about 4 miles to Orchard Lake Rd. Turn left on Orchard Lake Rd., then turn right into the second driveway. From north or east: take I-696 to the Orchard Lake Rd. exit. Then turn south on Orchard Lake Rd. At Grand River, turn left, then right to continue on Orchard Lake Rd. Continue south on Orchard Lake almost to 8 Mile Rd. Wolverine is the second to last driveway on the left.
