DIRECTIONS TO THE PIERSON CENTER, 32625 Seven Mile Rd., Livonia, MI 48152

From the north or east, 96/696 to 275, take the Seven Mile Exit, east past Farmington Rd. It will be on the south side of the street. It looks like an old school building.

Parking will be marked.

From the west: take M14/I-96 to the Farmington Rd Exit. Turn left (north on Farmington Rd and continue 3 miles to Seven Mile Rd. Turn right, Pierson Center will be on the right – looks like an old school.

From the South – Take 275 north to the Exit for Seven Mile Rd. Go east approximately 3 miles. Once you go over Farmington Rd, the Pierson Center will be on your right. It looks like an old school.

DIRECTIONS TO WOLVERINE DOG TRAINING CLUB, 20770 Orchard Lake Rd., Farmington Hills, MI 48336

From the north or east, I-96/696 to Orchard Lake Road, south 4 miles, including the jog at Grand River, continuing on Orchard Lake Road to building on the east side (Orchard Lake Trade Center);

From the south, I-96 to Merriman Road, north 3 miles to Seven Mile Road. Turn right and go to Merriman Rd and make a left. Just past Eight Mile Road, where Merriman changes to Orchard Lake Road, pass two buildings to Orchard Lake Trade Center on the right; from the west, I-275 to Eight Mile Road east five miles to Merriman/Orchard Lake Road, turn left, second building on the right (Orchard Lake Trade Center). Club is at the beginning of the building.
